8.2. Exposure controls

At the same time, there is an increase in the secondary side effects of ethanol. The metabolism of xylenes is enhanced by phenobarbital and 3-methyl-colanthrene-type enzyme inducers. Aspirin and xylenes mutually inhibit their conjugation with glycine, which results in a decrease in urinary excretion of metilippuric acid. Other industrial products can interfere with the metabolism of xylenes.
